Community Development / Peer Counselling / Capacity Building

The most recent success in the field of community and organization building was the co-organising and participation at the *European Intersex Meeting* in Riga (2014, facilitated by ILGA-Europe), which resulted in strengthening OII Europe as an organization and led to a joint statement with a recommendation for intersex inclusive anti-discrimination legislation as well as common European objectives. The empowering effect of this meeting diffused into the national organizations and giving their members the experience of being part of an European intersex community and so feeling more united, stronger, and less isolated in their respective national- and country-specific settings. We want to proceed on this path with the present application.

Strategic Plan OII Europe

Advocacy and Education

Since starting our work in 2012 we have established OII Europe as an NGO that gives expertise on intersex issues to political stakeholders within the EU and the CoE. With the upcoming issues paper in intersex by the Human Rights Commissioner of the CoE and the hopefully passing Maltese “Gender Identity, Gender Expression and Sex Characteristics Act” we will have many opportunities to advocate for intersex issues in Europe. We also plan to continue our work on the 2017 upcoming ICD reform for intersex individuals.

Community Development and Movement Building

We want to strengthen the already growing European Intersex Human Rights Movement and help it to evolve into an empowering movement, that inspires intersex ac-

tivists as well as supports intersex individuals in general by increasing their self-esteem and self-confidence. Europe includes a variety of languages and political structures. In most countries being intersex is still a taboo and intersex individuals are invisibilized. This amplifies the difficulty to transfer existing knowledge from one country to the other. We consider the proposed website- and video-project as the first step to generate a platform where activists from different countries can disseminate information in their own language as well as empower other intersex people by telling their stories while raising awareness of the broader public. Even though our working language is English, one important aspect as an international organisation is to be sensible of the variety of languages in our organisation. Therefore we believe it is essential to provide translations of relevant arguments for several non-English languages, in order to convey the European and international discourse to the contexts of our individual member states.

Advocating for the inclusion of “sex characteristics” as an anti-discrimination ground within the EU anti-discrimination legislation

Translating significant material from English in European languages and vice versa to make it available to the international intersex human rights movement
